Dear Sir/Madam,

I am pleased to inform you that, at the kind invitation of the Government of Seychelles, the twenty-sixth session of the RA I Tropical Cyclone Committee (RA I TCC-26) will be held in Mahé, Seychelles, from 6 to 8 October 2025.

As you are aware, the World Meteorological Organization (WMO) Regional Association I (RA I) called for a biennial session of the RA I Tropical Cyclone Committee for the South-West Indian Ocean (Resolution 5 (RA I-18) – Regional Association I Tropical Cyclone Committee for the South-West Indian Ocean). The function of the Committee may be broadly described as, among others, coordination and improvement of the tropical cyclone forecasting and warning services, and thereby, the reduction of casualties and damage resulting from tropical cyclones in the Region.

In this regard, as your country is represented in this Committee, I would like to invite you to nominate an expert Service/Institution, to attend the session. The nomination form is attached herewith (Annex). The provisional annotated agenda and the information note for participants will be made available in due course.
