Building on the success of the first *Consultative Meeting on Climate Science Information for Climate Finance* and in alignment with the WMO strategy to empower its Members, the World Meteorological Organization (WMO) is pleased to organize a combined training event entitled "*Climate Services to Enhance Access to Climate Finance*". Hosted by the China Meteorological Administration (CMA) in Beijing, China, the event will take place from 22 to 26 September 2025.

The event has two segments; the first segment (22–23 September 2025) will focus on the provision of climate services. Focused on knowledge-sharing and best practices under the Global/Regional Frameworks for Climate Services (GFCS/RFCS), this segment will support the implementation of National Frameworks for Climate Services (NFCS) through collaboration with the Standing Committee on Climate Services (SC-CLI) of the Commission for Weather, Climate, Hydrological, Marine and Related Environmental Services and Applications (SERCOM).

The second segment (24–26 September 2025) will be dedicated to enhancing the role of National Meteorological and Hydrological Services (NMHSs) in mobilizing climate finance especially at the national and regional levels based on the WMO publication *Enhancing the Role of National Meteorological and Hydrological Services in Mobilizing Climate Finance at the National Level* (WMO-No. 1365). This segment will also address the leadership development of Directors of NMHSs, improve strategic thinking, and foster partnerships.

The event will feature keynote speeches from the WMO Secretariat and invited experts, thematic presentations by NMHS representatives, interactive group activities and field visits. Participants will include Directors of NMHSs, representatives from SC-CLI/SERCOM, multilateral development banks, and the WMO Secretariat. Virtual participation will also be available for selected representatives from NMHSs, user sectors, and academia.

We encourage each NMHS representative to share their experiences on topics such as: (i) NFCS planning and implementation, (ii) leadership and management in NMHSs, (iii) women's leadership in climate services, or (iv) mobilizing climate finance.

Please note that, due to the current funding situation, the international travel costs of 15 NMHS representatives will be financially supported by the Trust Fund for the Belt and Road initiative. A reduced DSA will be provided to cover their accommodation and meals in China and participants will be responsible for any other expenses incurred.
