I am pleased to inform you that the fifth meeting of the Management Committee of the Intergovernmental Board on Climate Services (IBCS-MC/5) will be held at the European Centre for Medium-Range Weather Forecasts (ECMWF) headquarters, Shinfield Park, Reading RG2 9AX, United Kingdom, from 19 to 20 October 2017.

I have pleasure in inviting you to attend, as a member of the IBCS-MC, the abovementioned meeting. The agenda of the meeting and documentation for the session will be available at the dedicated website: http://gfcs.wmo.int/upcoming-events

The session will focus on the review of the recommendations of the mid-term review of the GFCS, being conducted by the University of Arizona, with a view to provide guidance on the necessary follow up actions.

It will also consider:

- (a) Establishment of specific task teams to facilitate the response to the recommendations of the mid-term review;
- (b) Status of implementation of the Priority Needs for the Implementation of the GFCS for the period 2016-2018;
- (c) Reporting of activities at national level and by partners, including the improvement of the current web-based platform;
- (d) Improving communication of the GFCS;
- (e) Regional coordination mechanisms for the implementation of the GFCS;
- (f) Resources mobilization;
- (g) Election of the IBCS Chair.

In accordance with Regulation 37 of the World Meteorological Organization (WMO) General Regulations "*expenses of attendance of members of working groups of constituent bodies at sessions of these groups shall normally be borne by the Members to which those members belong.*"

It would be appreciated if you could consider making arrangements to fund the cost of all or part of your attendance at this session of the MC. If this is not possible, WMO will consider providing financial support for this purpose upon request and subject to availability of funds, with priority to least developed countries, small island developing states, developing countries and countries with economies in transition.
