Subject: Meeting of the Expert Group on the WMO Global Multi-Hazard Alert System (EG-GMAS), 28-29 November 2018, WMO headquarters, Geneva, Switzerland

Action required: To confirm your participation or the participation of your designated GMAS Expert Group Member, preferably on or before **8 November 2018**

Dear Sir/Madam,

As you may recall, the WMO Executive Council at its seventieth session (EC-70) held in June 2018, adopted Decision 4 (EC-70) "Development of the Global Multi-hazard Alert System", requesting the Executive Council Working Group on Disaster Risk Reduction (EC WG/DRR) and the Expert Group on GMAS (EG-GMAS) to gather additional user requirements according to the Plan developed by EC WG/DRR based on the drafts developed by the EG-GMAS at its meetings held in October 2017 and March 2018 with support from the Secretariat.

In this regard, I am pleased to inform you that a meeting of the Expert Group on the WMO Global Multi-Hazard Alert System (EG-GMAS) will be held from 28 to 29 November 2018, at the WMO headquarters, Geneva, Switzerland.

The aim of this Expert Group meeting is to take stock of additional user requirements and further refine material for the consideration of the EC WG/DRR.

The expected outcomes of the Meeting are as follows:

- (1) Update user requirements according to the Plan developed by EC WG/DRR based on the drafts developed by the EG-GMAS;
- (2) Identify best practices from Members and assessments on how these may help deliver to the documented user requirements;
- (3) Propose options for the further development and implementation of GMAS including needed budget outlines;
- (4) Proposal for an updated version of the GMAS Concept.

I should therefore be grateful if you could examine the possibility of your participation, in your capacity as member of EG-GMAS or the participation of your designated EG-GMAS member in this Meeting. Further details regarding this Meeting will be sent directly to the participating members.

Provision for joining the meeting via BlueJeans will also be made available.
