Subject: Twenty-third session of the RA I Tropical Cyclone Committee for the South-West Indian Ocean (Maputo, Mozambique, 17-23 October 2019)

Dear Sir/Madam,

I am pleased to inform you that, at the kind invitation of the Government of Mozambique, the twenty-third session of the RA I Tropical Cyclone Committee (RA I TCC-23) will be held in Maputo, Mozambique, from 17 to 23 October 2019.

The Regional Association I, at its seventeenth session (RA I-17) in February 2019, decided to establish the Tropical Cyclone Committee (TCC) for the South-West Indian Ocean as one of its subsidiary bodies (Resolution 13, RA I-17). It also decided to keep Resolutions 3 (RA I-16) - Tropical Cyclone Operational Plan for the South-West Indian Ocean and 4 (RA I-16) - Technical Plan of RA I Tropical Cyclone Committee for the South-West Indian Ocean, in force.

The RA I TCC-23 is being organized as a special session, focusing on key issues identified through the post Tropical Cyclone Idai assessments and the follow-up remedial actions. In that context, the Committee will be requested to provide key recommendations which will form part of a major contribution to the roundtable meeting organized for a half day with the Ministers of the Member countries in the sub-region. The outcome of this roundtable will be conveyed to the African Union Commission (AUC) meeting to be held in Addis Ababa, Ethiopia (21-25 October 2019). In addition, these recommendations will support the discussion at the AUC meeting during the day dedicated to the enhancement of multi-hazard and impact-based services for disaster risk reduction. This will also contribute to the implementation of the sub-regional Global Multi-hazard Alert System (GMAS) in Regional Association I in line with Resolution 1, (RA I-17).

As your country is represented in this TCC, I would like to invite you to nominate an expert to attend this TCC-23 special session, which will include a high-level roundtable.

The provisional annotated agenda, which will also take into consideration the other items on the Tropical Cyclone Operational Plan and Technical Plan, as well as the information note for the session, will be made available in due course.

In accordance with WMO General Regulation 37, the "expenses of attendance of members of working groups of constituent bodies at sessions of these groups shall normally be borne by the Members to which those members belong". It is therefore hoped that these expenses will be borne by your Government. However, upon request, WMO could consider providing financial support (travel and a lump sum in lieu of per diem) for the participation of your nominated expert.
