Subject: Technical Planning Workshop on Development of Severe Weather Forecasting Programme (SWFP) in Central Africa, N'Djamena, Chad, 29 October – 1 November 2019

Action required: To nominate and complete/submit the Participant Nomination Form preferably **not later than 14 October 2019**

Dear Sir/Madam,

As you may recall, the Regional Association I, at its sixteenth session (RA I-16) Praia, Cabo Verde, February 2015, requested the Secretary-General to consider expanding the Severe Weather Forecasting Demonstration Project (SWFDP) to the rest of Africa. The SWFDP was subsequently implemented in West Africa. The WMO Congress at its eighteenth session, through Resolution 15 (Cg-18), decided to change SWFDP to Severe Weather Forecasting programme (SWFP).

Noting the progress made in the implementation of the SWFP in West Africa, RA I, at its seventeenth session (RA I-17), Cairo, February 2019, requested the Secretary-General to facilitate the implementation of the SWFP throughout Africa by the nineteenth World Meteorological Congress. Targeting next, the Central African sub-region, WMO is, therefore, planning to organize a technical planning workshop on the development of SWFP in Central Africa. It is proposed to hold the workshop in N'Djamena, Chad, from 29 October to 1 November 2019. The expected participants are representatives from National Meteorological and Hydrological Services (NMHSs) in Central Africa, advanced global Numerical Weather Prediction (NWP) centres and the Regional Specialized Meteorological Centre (RSMC) Dakar including the WMO Secretariat. The workshop will be conducted in French.

SWFP makes use of a "Cascading Forecasting Process" (global to regional, to national level) to engage advanced global and regional centres to provide NWP products and guidance to the NMHSs in a sub-region to improve forecasts and delivery of warning services at national and sub-national levels. The workshop will discuss key severe weather elements to be addressed by the SWFP and criteria for the threshold used in the guidance product (to be issued by the identified Regional Centre) for NMHSs in Central Africa.

I am, therefore, pleased to invite you to nominate the Head of the operational forecast unit of your Service to attend the workshop. I would appreciate if the attached Participant Nomination Form (see Annex) could be completed and submitted to the WMO Secretariat preferably **not later than 14 October 2019**.
