Dear Sir/Madam,

I have pleasure in informing you that, at the kind invitation of the Government of Panama, the forty-second session of the RA IV Hurricane Committee will be held in Panama City, Panama, from 30 March to 3 April 2020.

As you are aware, your country is a member of this Committee. I am, therefore, pleased to invite you to nominate an expert responsible for tropical cyclone forecasting and warnings to attend the session. Please find attached herewith the Nomination Form (see Annex) for this session. The provisional annotated agenda and the information note will be made available in due course.

In accordance with WMO General Regulation 31 (2019 Edition), the "expenses for the attendance of members of working groups of constituent bodies at sessions of these groups shall normally be borne by the Members to which those members belong." It is, therefore hoped that your Government would consider covering the cost of participation of your nominated expert. However, upon request, WMO could consider providing financial support (travel and a lump sum in lieu of per diem) for the participation of your nominated expert.

These persons therefore remain fully responsible for any expenses incurred as a result of events which are not attributable to attendance at meetings or performances of services on behalf of the Organization and for arranging such life, health and other forms of insurance as they consider appropriate".
