Noting the importance of calibration and maintenance of meteorological instruments for weather forecasting and climate monitoring activities, WMO is organizing a group training course on Instrument Maintenance and Calibration, at the Caribbean Institute for Meteorology and Hydrology (CIMH)/WMO Regional Training Centre (CIMH/WMO-RTC), Barbados from 15 August to 9 September 2016. Funding for the course is coming from the Government of Canada via a WMO fellowship trust fund.

The course is aimed at personnel who are responsible for the maintenance and calibration of meteorological instruments. It will equip participants with knowledge and practical skills in the science of measurement as well as the care and calibration of meteorological instruments. The course will be conducted in English. A fact sheet on the course is attached as an Annex for further reference. The course costs for the successful candidates will be covered by the fellowship trust funds.

As the training facility can only accommodate a limited number of participants, it may not be possible to accept more than one candidate per country. Applications from women and men are equally sought.

Course Duration: Four weeks.

Assessment: Assessment will be by continuous assignments, practical work and
