I am pleased to inform you that the World Meteorological Organization's (WMO) Climate Policy Advisors meeting will convene in virtual format from 1400 to 1700 Central European Summer Time (CEST), on Monday, 13 September 2021. The meeting will focus on the WMO contributions to the United Nations Framework Convention on Climate Change (UNFCCC) process, the Paris Agreement implementation, the Sendai Framework and Sustainable Development Goals (SDGs). In due course, you will receive an annotated agenda, the documents and a link to the meeting.

**Resolution 20 (Cg-18)** - WMO Contributions to the Provision of Climate Information and Services in Support of Policy and Decision-making, has established a Climate Coordination Panel (CCP) for coordination of WMO contributions to the provision of policy-and-decision-supporting climate information and services. The Executive Council at its seventy-third session (EC-73) included the Climate Policy Advisors in the CCP and mandated them to report annually.

The virtual meeting will serve as a consultative platform for the CCP's further role in guiding the provision of research and systematic observation, climate services for adaptation planning and high-level climate-related policy processes such as the UNFCCC, the Paris Agreement, climate-related aspects of the Sendai Framework for Disaster Risk Reduction and Sustainable Development Goals.
