Subject: Invitation to attend the WWRP PDEF face-to-face meeting in Vienna, Austria

Dear Sir/Madam,

I have the pleasure of inviting you, as a member of the World Weather Research Programme (WWRP) Working Group on Predictability, Dynamics and Ensemble Forecasting (PDEF), to participate in the PDEF face-to-face meeting to be held at the Hotel Klaus im Weinviertel, Wolkersdorf, in Vienna, Austria, from 27 to 28 April 2026.

The meeting will take place in person, with remote access available for those unable to attend in person. The objective is to review activities, develop a forward work plan, and align activities with the goals of the WWRP Implementation Plan for 2024–2027. The meeting is scheduled ahead of the European Geosciences Union (EGU) conference and will be followed by the Diabatic workshop.

If required, WMO may provide travel support in the form of the most direct and economical air ticket, and Daily Subsistence Allowance (DSA) to cover accommodation and meals. Participants are responsible for arranging any necessary visas. Further logistical details will be shared in due course.

Regarding insurance coverage for non-staff members, may I draw your attention to the following:

Non-staff members of WMO who are authorized to travel at the Organization's expense and/or who are receiving a DSA from WMO must ensure they are fully responsible for expenses incurred in the event of death, illness or injury during official travel and attendance at meetings on behalf of the Organization. They are, therefore, fully responsible for arranging life, health, and accident, as well as any other forms of insurance with an adequate level of coverage for the duration of such meetings and events.

WMO liability is limited to the performance of services or attendance at a meeting on behalf of the Organization, is covered by an injury and illness benefit insurance which provides limited coverage for medical, emergency, and supplementary official travel expenses.
