As part of the preparations for the Seventh High-Level Session of the Open Consultative Platform (OCP-HL-7) of WMO, to be held in the margins of the [Eightieth Session of the Executive Council \(EC-80\)](#), the WMO Secretariat is conducting a targeted pre-consultation process with EC Members and private sector stakeholders.

OCP was established by [Resolution 79 \(Cg-18\)](#) in 2019 as WMO mechanism for facilitating dialogue between stakeholders across the weather, climate and water enterprise. OCP-HL-7 marks a step forward in this process – moving from dialogue toward a results-oriented approach to Public-Private Engagement (PPE). The objective of the dialogue is to inform the evolution of WMO future approach for PPE at the Twentieth Session of the World Meteorological Congress (Cg-20) in 2027.

To move forward with this objective, we consider a clear and adequate understanding of the perceptions of Members, partners, and stakeholders to be a necessary step. For this reason, an online questionnaire has been developed to gather structured input from EC Members and the private sector.

The questionnaire covers priority collaboration areas related to weather, climate and water, key barriers to engagement, the expected role of WMO in facilitating PPE and preferred engagement mechanisms. It takes approximately 10 minutes to complete.
