Dear Sir/Madam,

I have the pleasure to inform you that, following a kind offer to host by the Permanent Representative of the United Kingdom of Great Britain and Northern Ireland with the World Meteorological Organization (WMO), the third meeting of the Services Commission (SERCOM) Standing Committee on Services for Aviation (SC-AVI-3) will be held at the Met Office headquarters, Exeter, United Kingdom from 12 to 14 September 2023. This will be an in-person meeting only, with no online or hybrid component.

The Provisional Agenda (see Annex 1) is enclosed herewith for your information.

The membership of this group (see Annex 2) includes an expert from your country who has been nominated with your approval to serve on this group. I should, therefore, be grateful if you would kindly examine the possibility of his/her attending the meeting.

In accordance with WMO General Regulation 31, *Basic Documents No. 1* (WMO-No. 15), the "expenses of attendance of members of subsidiary bodies of constituent and additional bodies at sessions of these bodies shall normally be borne by the Members or the international organization to which those members belong". It is, therefore, hoped that these expenses will be borne by your Government, should your expert attend.
