Dear Sir/Madam,

In continuing WMO's support to capacity development, the WMO Education and Training (ETR) Office has designed a training course on the implementation of the competency approach. To bridge the gap between theory and practice, the course will focus on the principles of Competency, including On-the-Job Training and Competency Assessment by following the outlines in the Guide to Competency (WMO-No. 1205) and Compendium of WMO Competency Frameworks (WMO-No. 1209). With the kind support of the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), it will be take place at the WMO Regional Training Center of the Philippines (RTC-Philippines), in Manila, from 2 to 6 December 2024.

Nomination to be received by 4 November 2024

The target is to host up to 25 experts from the WMO Regional Association V (South-West Pacific) Member countries developing skills, applying and adapting the specific tools to any operational activity in National Meteorological and Hydrological Services (NMHSs) to support implementation of the competency approach in their NMHSs by:

- Raising awareness and understanding of the WMO Basic Instruction Package (WMO 1083) and Competency Frameworks, as presented in the Compendium of WMO Competency Frameworks WMO-No. 1209.
- Assisting the implementation of the WMO Competency Frameworks.

The course will be conducted in-person, for a duration of one week, from 2 to 6 December 2024. Annexes I and II to this circular letter briefly describe the course, its format, expected learning outcomes, and qualifications to be attained.

Any interested candidate from countries within RA V should first apply by sending a duly completed application form (Annex III) with the relevant attachments to the WMO Education and Training Office (tra@wmo.int) no later than **4 November 2024**. Any applications received after this date will not be considered. All applications will be reviewed by the WMO Education and Training Office and selection for attendance will be made on a competitive basis.

To: Permanent Representatives of RA V Members with WMO (English-speaking countries – Limited distribution)

Please note that while we encourage Members to cover the expenses of their participants to attend the course, WMO is prepared to support one participant from NMHS Members of RA V with priority to those working in the operation of capacity development-related areas in particular competency implementation. The selected successful participants will be notified and contacted by WMO for the preparation of travel logistics. Thereafter, the selected candidates will receive a Request for Financial Assistance (RFA) form to complete and send back to WMO along with the admission letter and a copy of the selected candidate's passport, no later than **6 November 2024**. Any RFAs received after this date will not be considered.

Regarding insurance coverage for non-staff members, may I draw your attention to the following:

Non-staff members of WMO who are authorized to travel at the Organization's expense and/or who are receiving a DSA from WMO must ensure they are fully responsible for expenses incurred in the event of death, illness or injury during official travel and attendance at meetings on behalf of the Organization. #### The WMO Hands-on Training on Competency Approach Implementation

#### **Course description**

The WMO hands-on Training on Competency Approach Implementation is a short course that is organized by the WMO Education and Training Office in collaboration with the kind support of the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA). The course will take place in Manila, in the Philippines. The in-person course is organized to raise awareness and understanding of the WMO Competency Frameworks as well as to support its implementation in WMO Regional Association V. The course will allow the participants to familiarize themselves with the competency approach and implementation, particularly the competency assessment. Participants will also be provided with the opportunity to apply the principles of competency approach into real environment for the benefit of their organizations.

#### **Course Format**

The WMO hands-on Training on Competency Approach Implementation will be an in-person course which will run from 2 to 6 December 2024.

The trainees must show satisfactory attendance, progress and timely and satisfactory completion of tasks and activities. They are recommended to bring their own laptop.

#### **Expected Learning outcomes**

By the end of the course, the trainees will have successfully achieved the following outcomes:

- 1. Apply the principles of the competency approach and implementation as defined by  $\ensuremath{\mathsf{WMO}}$
- 2. Understand the stages of competency assessment
- 3. Understand the challenges and benefits of competency assessment
- 4. Apply the stages of competency approach in developing a competency management approach for the organization

#### Competencies attained and certificates issued

After successful completion of the course, participants will receive a certificate stating the underpinning skills that support the WMO Competency Framework implementation.

#### **Target Audience**

Staff with relevant roles in competency framework implementation OR with potential to influence capacity-building initiatives in their organizations including roles in human resources, training and education from WMO Regional Association V NMHSs.

#### Instructors

A trainer from WMO will be the instructor of the course. Additional content experts will be brought in for specific portions/subjects of the course.

#### Working language

The course will be conducted in English. No translation in other languages is offered.

#### **Entry requirements**

- Involvement in human resources and capacity development.
- Good skills in English reading, written and spoken (language comprehension).
- All this needs to be verified by proof of CV and qualifications.

Work experience: relevant work experience in operational and services in climate, weather and water is preferred.

### Useful resources in preparing for the course

A laptop or desktop computer with Microsoft Office or equivalent (Word processer, PowerPoint Presentation, etc) good memory capacity and storage (an external storage is advised). A laptop would be preferable as it can be used during in the interactive learning activities in the face-to-face phase.

#### **Procedure for application**

The applications must include:

- A letter of motivation in English limited to 200 words:
- A CV.
- Relevant certified qualifications.
- A nomination letter from the relevant Permanent Representative (PR).
