I am pleased to inform you that WMO plans to organize a training workshop on the WMO Information System (WIS) 2.0 in Ankara, Türkiye, from 17 to 21 November 2025.

The training course will address the capacity-building needs of National Meteorological and Hydrological Services' (NMHSs) staff implementing WIS 2.0.

The purpose of this training course is to help WMO Members build capacity by:

- (1) Improving their understanding of the WIS 2.0 architecture;
- (2) Developing skills to install and configure the WIS 2.0 box software;
- (3) Developing skills to operate a WIS 2.0 node.

The training course is designed to be practical and highly interactive. Participants will be expected to work independently or in groups on the above and other activities.
