Subject: Extraordinary session of the Executive Council in 2024 (EC-Ext.(2024))

Action required: Inform on participation and register for the EC-Ext.(2024)

Dear Sir/Madam,

I would like to convey, on behalf of the President, that after consulting with the Executive Council (EC) members and with the agreement of the three Vice-Presidents, and in accordance with Article 15 (b) of the WMO Convention (*Basic documents, No. 1* (WMO-No. 15)), it has been decided to organize a virtual extraordinary session of the Executive Council (EC-Ext(2024)) on 24 January 2024.

The sole agenda item will be the approval of the Secretary-General's proposed appointees for the positions of Deputy Secretary-General and Assistant Secretary-General. Candidates for both positions are currently under consideration following an open competition process launched on 26 September 2023 conducted by the Secretary-General elect. The provisional agenda and its annotation is provided in the annex.

The procedure for approving the proposed appointees, established by decisions adopted at the Ninth World Meteorological Congress (Cg-IX) (General Summary, paragraph 10.1.15) and the Tenth World Meteorological Congress (Cg-X) (General Summary, paragraph 9.4.9) has already been provided to members in previous correspondence sent by the President on 31 October 2023.

It is expected that the commencement of duty for both positions will be the beginning of 2024, or as soon as possible thereafter.

This extraordinary session will be held as an "in-camera" session and Observers will not be permitted to attend the session. EC members who cannot attend the session should designate an alternate and inform the Secretariat in advance.

Please note that the provisional annotated agenda, documents for the session as well as information on the videoconferencing arrangements are posted online on the session website. The scheduled session will be held online as a single meeting from 1100 to 1400 UTC/GMT.

EC members are kindly requested to:

- (1) Inform the Secretariat of their participation and provide the names of their alternates and/or advisers through a signed letter, and;
- (2) Pre-register themselves or their alternate individually, through the online registration that is now open and will close on **10 January 2024**. The link to the online Event Registration System, the username and password that were sent by email to the Permanent Representatives with WMO remain valid for all upcoming WMO meetings.
