Subject: Your contribution for the preparation of the WMO Strategic Plan 2020-2023

Action required: Online Survey be completed **by 25 August 2017**

Dear Sir/Madam,

I have the pleasure to request your contribution to the WMO Strategic Plan 2020-2023 prepared by the Executive Council Working Group on Strategic and Operational Planning, together with the WMO Secretariat. It is intended to place emphasis within these plans on concrete actions that address the needs of the WMO Members and ensure that WMO Secretariat resources are prioritized according to the needs of Members.

I consider that it would be very useful at this stage of the process to have some input from the entire membership of the Organization to help in identifying specific deliverables, with related milestones, that might be outlined in the Plan, to a level of detail appropriate to the document and in line with Long-Term Goals (LTGs) and Strategic Objectives.

Therefore, an online survey is being launched through a link from this letter. The outcome of this survey will be a valuable input into the further drafting of the Strategic Plan and the future Operating Plan, and into resource allocation plans and the WMO Budget. It will also be very useful in any consideration of the future of WMO constituent bodies and their work programmes.

The questions set out in the Survey aim to collect your views on a variety of topics relevant to the planning process.

One issue that receives special attention in the later part of the Survey is that of public/private activity and partnerships. Private sector actors are increasingly interested in providing weather, climate and hydrological services. There is also private sector activity in weather observation programmes which poses a challenge from the perspective of WMO data policy. The information collected from this section will be used as a basis for planning WMO public/private partnership strategy which would take into account the diversity of the current and future practices of the Members.

In making your responses, it should also be remembered that the content of the Strategic Plan will be governed by priorities and guidance that the EC has already established.

As the Strategic Plan is a high-level document, it is expected that there will be a balance between broad objectives, priorities and activities, and concrete actions.


