As part of the preparation for the extraordinary session of the World Meteorological Congress (Cg-Ext.(2012)), which will be held from 29 to 31 October 2012 at the International Conference Centre of Geneva (CICG), a "Dialogue on Climate Services Users and Providers: towards implementation of the Global Framework for Climate Services" is being organized from 26 to 27 October 2012.

The Dialogue will provide an opportunity for users and providers to learn from one another about the challenges and opportunities for the production and enhanced utilization of climate services in decision making, particularly in the four priority areas of the Global Framework for Climate Services (GFCS) (agriculture and food security, health, water and disaster risk reduction). In addition, the Dialogue will establish a solid foundation for the intergovernmental deliberations on the GFCS that will take place at the extraordinary session of Congress.
