This publication was produced by the WMO PWS Programme, as agreed during the "Third Meeting of the World Weather Information Service (WWIS) Web Hosts (WWIS-3)", which was held in Offenbach, Germany, 18-20 October 2011. The Guidelines are targeted at National Meteorological and Hydrological Services (NMHSs), and are intended to demonstrate the benefits that NMHSs gain by participating in WWIS, and to provide step-by-step guidance for a NMS wishing to either join the WWIS initiative or to enhance its level of participation. Templates of the standard forms that NMHSs would need to complete to join or enhance participation in the WWIS are also provided.

In order to benefit most from this publication, you may wish to consider assessing the level of participation of your NMS in the WWIS activity with the intention of enhancing the contribution from your Service to it in terms of:

- Starting to participate in the WWIS initiative, if your Service is not already participating;
- Increasing the number of cities for which NMHSs provide climate information and weather forecasts;

cc: Hydrological Advisers to Permanent Representatives

- Providing more climate information;
- Increasing the frequency of updating forecasts;
- Providing same-day weather forecasts;
- Providing links to the WWIS Website from the Website of your NMS; and / or,
- Informing local media and other users, such as the tourism industry, of WWIS and encouraging its usage by these users.

I am confident that you will find this publication useful for enhancing the participation of your Service in the WWIS activity of NMHSs.
