## Dear Sir/Madam,

I am pleased to inform you that the sixty-sixth session of the WMO Executive Council (EC) held in Geneva, Switzerland from 18 to 27 June 2014 approved new Terms of Reference for its Panel of Experts on Education and Training (ETR Panel), including formalizing a nomination and selection process for ETR Panel members. EC will select new members of the ETR Panel in June 2015. The appointment of the members of the ETR Panel will be through advertisement of the vacancy positions to Permanent Representatives of Members with WMO (PRs) and the presidents of regional associations (RAs) and technical commissions (TCs). This process is designed to provide a more transparent method of selection and to attract applications from a wide population of individuals with skills and expertise in development, delivery, evaluation, oversight and governance of higher degree education and vocational training matters, including knowledge of the operational and strategic direction of the WMO.

The ETR Panel will be composed of twelve members and a Chair, traditionally the President of WMO. The ETR Panel members will sit in a personal capacity. The ETR Panel sessions and documents are in English only, thus a high level of fluency in written and oral English is required. The members of the ETR Panel will be appointed by the EC for an initial period of four years that can be renewed only once for another period of four years. To provide continuity as we move to the new system, EC-66 agreed that current ETR Panel members who had already served eight years could be considered for the next ETR Panel as an exceptional measure.

The members of the ETR Panel shall not receive any remuneration from WMO for their services. However, if required, WMO will meet the travel and subsistence costs involving their attendance to the meetings of the ETR Panel, in accordance with WMO travel rules. Sessions of the ETR Panel are normally held every two years, usually at one of the WMO Regional Training

Centres or at a WMO related training partner institution. The next scheduled ETR Panel session is in the first quarter of 2016. ETR Panel members will be expected to lead reviews of WMO Regional Training Centres and, on an intersessional basis, actively contribute to any working groups or task teams the ETR Panel could create to further its work.
