Dear Sir/Madam,

The purpose of this letter is to inform you of the convening of the fifteenth session of the Commission for Hydrology, scheduled to be held at the Barceló Aran Mantegna Hotel, in Rome, Italy, from 7 to 13 December 2016, and to seek your assistance in making this a productive and successful session of the Commission.

In an attempt to obtain a greater level of debate and discussion into the various topics it will consider, the Commission has once again established a pre-session discussion. Please note that this mechanism is intended to provide the basis for a better understanding of new and upcoming issues to be treated by the Commission. It thus provides an opportunity for early debate on key topics and issues and lays a foundation for more detailed discussion during the session.

The Commission is keen to involve as many experts as possible in its work and therefore encourages nominations for membership of both its Advisory Working Group (AWG) and its Open Panel of CHy Experts (OPACHE).

There is also an opportunity to access accommodation at rates well below normal Rome hotel rates, and details are provided herein.

Pre-session discussion

In preparation to its previous sessions in 2008 and 2012, the Commission launched a forum on the Internet to promote the debate on the priority topics to be discussed during the session, gather inputs from a broader audience of experts and professionals, and give an opportunity to those countries which would have not been able to participate to voice their concerns and opinions.

In view of its positive outcome, it has been decided to repeat the experience of pre-session discussion through the web for the upcoming fifteenth session. I would like to request you to encourage members of CHy and other experts from your country to participate in this pre-session discussion at http://www.whycos.org/wordpress/?page_id=758 and provide their views on any of the several topics posted for debate. Their opinions will be presented to the session and contribute to the debate and decisions to be taken by the Commission.

Nomination of experts or possible members of AWG

In order to efficiently and effectively carry out the activities of the Commission during the intersessional period, the Commission is likely to adopt the following procedure, as proposed by the AWG:

- 1. The Commission will decide on the focus areas under which it will carry out its work during the next intersessional period;
- 2. It is also likely to decide on establishing again an Advisory Working Group to coordinate, guide and monitor the implementation of the various activities of the Commission during the next intersessional period from among the experts nominated by Members;
- 3. In order to streamline its structure, it will continue working with the experts designated for the Open Panels of CHy Experts (OPACHEs) established during the last session, but will merge the existing panels into a single OPACHE. Naturally, it will welcome new experts into this panel;
- 4. The AWG will call on experts from the above panel to undertake specific tasks in the work plan of the Commission.

While the Commission session will have the final word in deciding its programme of work, the Advisory Working Group has identified and proposed the following three focus areas to be considered for the next intersessional period:

- 1. Coordination and Implementation Support;
- Measurement, Monitoring and Infosystems;
- 3. Hydrological Applications, Products and Services.

Attendance of representatives of Members at the session is therefore of paramount importance to ensure that the decisions taken by the Commission reflect the needs and requirements of the hydrological community.

I am pleased to hereby solicit nominations for the potential members/positions for establishing the Advisory Working Group for the next intersessional period. In considering your nominations, you may wish to recall the WMO Gender Equality Policy approved by the seventeenth World Meteorological Congress in 2015, which calls for technical commissions to make efforts "to ensure that a minimum of at least 30 per cent of the members of their working structures is female and that this percentage rises progressively within each financial period. The longer-term objective will be to reach parity between male and female members".

For easy reference a summary of the proposed structure of the Commission is included in Annex 1 to facilitate the nominations. A more detailed description of the proposed future programme of work and structure of CHy is available in the report of the third session of the AWG, available at the following link:

Experts appointed to the OPACHEs at previous CHy sessions would continue to serve on the new unique OPACHE, unless we are advised otherwise. You can review who those country by consulting the Country Profile Database experts are for your (https://www.wmo.int/cpdb/). Members are also requested to nominate new candidates for the OPACHE. It would be appreciated if, in consultation with your Hydrological Adviser and/or your National Hydrological Service, you could submit nominations of experts using the attached Nomination Form given in Annex 2. It is also recognized that the experts nominated may come from any Service or Institute from your country. To ensure that information on the background of the experts is available in a uniform manner, it would be appreciated if, in addition to sending the Nomination Form, you could request each of the experts you wish to nominate to fill in electronically the Professional Information Form (available in English only) which can be downloaded at the following website:

In considering the nomination of experts I would also like to remind you that the Nomination Form and the Professional Information Forms should be submitted preferably by **30 November 2016** in order to ensure that this information will be available for consideration during CHy-15.

In the event that you do not envisage at this time that your country will be represented at CHy-15, it is particularly important that you consider favourably this invitation to nominate experts to the OPACHE and candidates for position as AWG members. Such a nomination will ensure that experts from your country are considered when selections are made at the session. I hope you appreciate that the ultimate decision regarding the establishment and composition of the Advisory Working Group rests with the Commission.

Information on accommodation

With respect to accommodation, it is advisable to make an early booking. As usual, participants are responsible for making their own arrangements. PROPOSED CHy STRUCTURE FOR THE INTERSESSIONAL PERIOD 2017-2020

Composition of the Advisory Working Group (AWG)

The proposed composition of the AWG is:

- 1. President of CHy;
- 2. Vice-president of CHy;
- 3. Members of the Advisory Working Group (tentatively seven);

Supported by one OPACHE.

Organization of activities

Activities will be organized under three generic themes:

- 1. "Coordination and Implementation Support", addressed by the president of CHy, the vice-president of CHy, and an AWG Member covering the role of "Project Facilitator";
- 2. "Measurement, Monitoring and Infosystems" addressed by three AWG members;
- 3. "Hydrological Applications, Products and Services" addressed by three AWG members.

It is strongly recommended that CHy-15 limit the workload assigned to each of the three groups mentioned above to not more than six activity areas, to ensure that the identified priorities are accomplished.

Furthermore, two additional sets of desired outputs would be achieved by:

- 1. A set of activities to be supported by the Secretariat, with support of experts from the OPACHE, without direct involvement of AWG members;
- 2. A set of activities that in light of limited resources could be implemented only if one or more Members will volunteer to lead their implementation.
