I wish to refer to the World Meteorological Organization (WMO) circular letter ref.: 06862/2018/OBS/OSD/IMO/TECO-2018 dated 15 March 2018, announcing the WMO Technical Conference on Meteorological and Environmental Instruments and Methods of Observation (CIMO TECO-2018), which will be held in Amsterdam, the Netherlands, at the kind invitation of the Royal Netherlands Meteorological Institute (KNMI), at RAI Amsterdam Convention Centre, from 8 to 11 October 2018.

The Conference will take place in conjunction with the Meteorological Technology World Expo organized by UKi Media & Events, from 9 to 11 October, and the Second Satcom Forum from 9 to 11 October 2018. CIMO TECO-2018 will also include the presentation of the 2018 Professor Dr Vilho Väisälä Awards.

The authors are invited to submit their extended abstracts (camera-ready papers) to be included in the conference's proceedings as early as possible, but not later than **10 September 2018**.

Priority for this assistance will be given to those who are presenting papers at the conference. Otherwise, please note that requests for financial assistance can only be considered within the limits of available resources for those requests submitted by the relevant Permanent Representative of the participant and received at WMO Secretariat before **15 July 2018**. It is unlikely that more than one participant per country could be considered for financial support.

I look forward to the participation of your expert(s) at CIMO TECO-2018, a technical conference offering a unique opportunity for exchange of information on the latest developments in instrumentation, observing methods and systems. Interaction during CIMO TECO-2018 will also be supporting the WIGOS measurement community initiative to preserve knowledge of existing environmental measurement methodologies of existing technical commissions, in the WMO transition process to a new structure.
