I am pleased to inform you that the Met Office (UK) and the World Meteorological Organization (WMO) will be jointly conducting an online Leadership and Management Training Programme for middle and senior managers in the National Meteorological and Hydrological Services (NMHSs) in developing countries, which will comprise a series of four 90 minute webinars between 2 March to 4 May 2022 and will be conducted in English. Please note these dates are provisional and may be subject to change.

The webinar series will focus on providing support and guidance for NMHSs developing project proposals for both government departments and potential development partners. - Webinar 3 (13 April 2022): Negotiating and presentation skills.
- Webinar 4 (4 May 2022): Reflection on experiences and discussion around potential proposals. This webinar will also look at the skills needed to develop effective bids/proposals and considerations for addressing any gaps.

Please note that due to the nature of the training, spaces will be limited to 25 people, but hopefully there will be future opportunities for attendance following this initial programme. The accepted nominees will be provided with further details in due course by the organizers.
