This milestone report is designed to gather key hydrological information about changes in our water environment. The WMO's 2022 State of Global Water Resources report, building on its successful pilot from the previous year, is an annual WMO initiative that provides an independent, comprehensive, quantitative assessment of the global water resources. This report, a key commitment of WMO's UN 2023 Water Conference Water Action Agenda, has expanded its scope to include groundwater, evapotranspiration, soil moisture, reservoirs, and extreme hydrological disasters in addition to the components from last year's report. It relies on a combination of in-situ data, modeling systems, and remote sensing to bridge data gaps globally. Although there's been increased data sharing, uniform global hydrological observations remain our goal, which requires more investment in monitoring and data sharing. The report offers practical utility and policy guidance for global decision-makers, aligning with the UN's vision for an early warning system and supporting Sustainable Development Goals related to water and climate. It also quantifies environmental and anthropogenic impacts on hydrological conditions and complements the State of the Climate Report, aiding integrated water and climate action planning globally.
