Summary outcomes of IBCS-2

Sir/Madam,

I have the honour to inform you that the second session of the Intergovernmental Board on Climate Services (IBCS-2) was held from 10 to 13 November 2014 in Geneva. The session took a number of important decisions to advance the implementation of the Global Framework for Climate Services (GFCS).

The meeting was attended by 199 delegates from Member States and Territories, 24 representatives of International Organizations (as Observers).

The draft provisional report of IBCS-2 can be accessed through the World Meteorological Organization (WMO) website at http://ibcs-2.wmo.int/. The final abridged report with resolutions will be shortly finalized in all official WMO languages and posted on the WMO website.

Following the decisions taken at the extraordinary session of the World Meteorological Congress (Cg-Ext.(2012)) and the first session of the Intergovernmental Board on Climate Services (IBCS-1), the second session of the IBCS:

- (a) Approved the revised terms of reference of the Partner Advisory Committee (hereunder referred to as the "PAC") of the IBCS, which specify functions, responsibilities, membership, mode of operation and financing of the PAC;
- (b) Agreed on the means through which GFCS Partners and Stakeholders with technical capability can play a role in the implementation of GFCS, specifically through participation in technical committees established for specific questions as might be required, as per practice of WMO Technical Commissions;
- (c) Agreed on the interaction between the IBCS and the constituent bodies of WMO;
- (d) Approved revised terms of reference of the Management Committee, to strengthen the interface and linkages with the PAC;

- (e) Agreed that urban activities related to climate be included as a specific cross-cutting element within the priority areas of the GFCS;
- (f) Agreed on the further development of the Energy exemplar and on presenting a proposal to the Seventeenth World Meteorological Congress for consideration of Energy as an additional priority sector for GFCS;
- (g) Agreed on the creation of an ad-hoc Task Force or Working Group on Monitoring and Evaluation;
- (h) Considered the GFCS budget for 2015 and the Operational and Resource Plan for 2016-2018 and recognized the need for providing resources to support implementation of projects and activities, the governance structure of the GFCS and the GFCS Office;
- (i) Requested the IBCS Management Committee to incorporate gender-related recommendations into the GFCS;
- (j) Elected the Chair, two Co-Vice-Chairs and kept the membership and composition of the Management Committee of the Board as approved by IBCS-1;
- (k) Agreed to have ordinary plenary meetings of the IBCS only once in the intersessional period prior to WMO Congress sessions and for the Management Committee to meet once a year to provide advice, oversight and management of implementation of the GFCS in the intersessional period.

A table of the major decisions and required follow- up is provided as Annex I for your attention, as well as the list of the Members of the Management Committee and their principal members (Annex II).

On the Implementation of the GFCS, IBCS-2:

- (a) Agreed to focus on implementation of concrete projects at regional and national levels in an initial set of countries to learn lessons and develop *a proof of concept* that could be replicated across regions and in other countries;
- (b) Agreed to include urban activities related to climate as a specific cross-cutting element within the priority areas of the GFCS;
- (c) Agreed to develop an Energy Exemplar with a view to presenting a proposal to the Seventeenth World Meteorological Congress for consideration of Energy as an additional priority sector for the GFCS;
- (d) Agreed to create an ad hoc Task Force or Working Group on Monitoring and Evaluation to oversee the updating of the Monitoring and Evaluation process and criteria for the GFCS:
- (e) Agreed on the resources plan for the GFCS for the period 2015-2018 to support implementation of project and activities, the functioning of the governance structure of the GFCS and Secretarial support. For the successful implementation during the period 2015-2018 almost USD 140 million will be required through direct contributions to the GFCS Trust Fund or through contributions of various partners to the implementation of GFCS-related projects and activities;
- (f) Noted the outcomes of the Conference on the Gender Dimensions of Weather and Climate Services (Geneva, 5-7 November 2014) and requested the IBCS Management Committee to incorporate gender-related recommendations into the GFCS

Implementation Plan and to ensure that GFCS projects and activities are gendersensitive;

(g) Decided that its Chair would submit a document to Congress for its consideration on the following topics: frequency of IBCS ordinary sessions; GFCS budget and workplan; and links to the Executive Council, technical commissions and regional associations.

Other highlights of the session

The Board noted the significant progress made with the implementation of the GFCS. Despite this progress, however, coordination to ensure planning, exchange of information and linkage of initiatives by an increasing number of stakeholders to more effectively develop and apply climate services for decision-making worldwide remains a challenge. A Meeting on Implementation Coordination of the GFCS was held from 29 September to 1 October 2014 at the WMO Secretariat. Nearly 100 programme managers from the United Nations and international agencies, GFCS focal points and representatives from the respective technical structures of partner agencies leading/supporting the four priority areas (Agriculture and Food Security, Water, Health and Disaster Risk Reduction) participated, including representatives from WMO Technical Programmes, Technical Commissions, Regional Associations, and Executive Council bodies. The Meeting reviewed over 100 projects on-going in 16 illustrative countries whose components directly support implementation of GFCS thematic pillars (User Interface Platform; Climate Services Information System; Observation and Monitoring; Research, Modelling and Prediction; and Capacity Development) and priority areas, with a combined budget of over USD 700 million. This survey of country-level programmes brought into sharp focus a number of clear needs:

- (a) The need to effectively coordinate and link the activities of various actors who are supporting climate services-related initiatives at global to the national levels such that these activities result in the establishment of enhanced climate services, given that across the projects being implemented in many regions and countries there remains a need to effectively address gaps, reduce duplication and identify areas where technical/scientific support, planning and coordination are needed;
- (b) The need for effective ways of coordinating efforts to support the GFCS pillars and priority areas of the GFCS and on-going projects at national level;
- (c) The need of a dedicated mechanism through which partners, including members of the Partner Advisory Committee (PAC), can coordinate technical, scientific, advisory services and planning support for designing and implementing climate services at the national level more systematically advisory services of WMO's Technical Commissions and Programmes can be channeled to support GFCS implementation at national level.

I hope you will find this information useful and look forward to the continued cooperation between WMO, Members and partners in supporting the implementation of this critical global initiative.
