Your Excellency,

I have the honour to inform you that Phase II of the eighteenth session of Regional Association I (Africa) (RA I-18(II)) of the World Meteorological Organization (WMO) will be held online through a remote platform from 23 to 26 August 2021. Phase I of the eighteenth session of the Regional Association I was held from 18 to 19 March 2021.

The provisional agenda and the explanatory memorandum for Phase II of the RA I-18 session will be accessible on tab "Part II" of the session website. Instructions and guidelines on the use of the online platform will also be made available on the session website.
