I wish to notify that registration for ICAWS-2017 will be available at the conference website, starting from 15 June 2017. Participants for the conference are invited to register via the website as soon as possible, but not later than **15 September 2017**. Please bear in mind that the conference facilities can accommodate a limited number of participants. Therefore, priority will be given to the experts with papers that have been accepted, and in case of a significant interest, participants will be selected on a first-come, first-served basis.

I am pleased to inform you that WMO has limited funds available for the provision of financial support to a few participants from least-developed and developing countries. Priority for this assistance will be given to those who are presenting papers at the conference. I kindly urge you to consider meeting the cost of travel expenses, such as air ticket and/or per diem for the participant(s) of your respective Service. Otherwise, please note that requests for financial assistance can only be considered within the limits of available resources for those requests submitted by the relevant Permanent Representative of the participant and received before 7 July 2017. Following selection related to the provision of financial assistance, the WMO Secretariat will liaise directly with those participants for whom financial requests were received from their Permanent Representative, and inform them of the decision made.

I look forward to the participation of your expert(s) at ICAWS-2017, the event that will enable exchange of experiences and knowledge on AWSs, and thus support strengthening collaboration among different communities contributing to the WMO Integrated Global Observing System (WIGOS).
