تحية طيبة وبعد،

يسرني إبلاغكم أن جمهورية الصين الشعبية ستستضيف دورة تدريبية دولية بشأن خدمات الأرصاد الجوية للطيران، في الفترة 9-19 نيسان/أبريل 2013 في مركز التدريب التابع لهيئة الأرصاد الجوية الصينية (CMATC)، بيجين وهو مركز التدريب الإقليمي (RTC) للمنظمة العالمية للأرصاد الجوية (WMO) في الصين.

والهدف من الدورة هو تعزيز قدرات المشاركين على تطبيق نواتج التنبؤات الجوية وتفسيرها لأغراض الطيران وتعزيز التنبؤ الآني والقدرة على التنبؤ بالطقس على المدى القصير وبالطقس المحلي القوي في البلدان النامية. وستدار الدورة باللغة الإنكليزية.


وسيعفى المشاركون المقبولون الذين يتلقون "إخطارات بالقبول" من مركز التدريب الإقليمي (RTC) التابع للمنظمة (WMO) في بيجين من رسوم التدريب. وستقدم الحكومة الصينية للمشاركين، بناء على الطلب، دعماً محلياً من قبيل توفير أماكن الإقامة والوجبات ومصروف للجيب (مبلغ 50 يواناً صينياً يومياً) في بيجين. ويعتمد مركز التدريب الإقليمي (RTC) التابع للمنظمة (WMO) في بيجين طلباً واحداً من كل بلد نام أو طلبين من كل بلد من أقل البلدان نمواً فيما يتعلق بالدعم المحلي. وفيما يتعلق بالتكاليف الأخرى، مثل بطاقة السفر الدولية ذهاباً وإياباً، وتكاليف تأشيرة الدخول، والرعاية الطبية، والتأمينات، والمرتبات المحلية للمشاركين، فينبغي أن يتحملها المشاركون أو حكوماتهم. ويُنصح المشاركون بالوصول إلى بيجين في 8 نيسان/أبريل 2013 ومغادرتها في 20 نيسان/أبريل 2013. وللحصول على معلومات تفصيلية عن هذه الدورة، الرجاء الرجوع إلى "معلومات التسجيل" (المرفق الأول).

ENROLMENT INFORMATION

INTERNATIONAL TRAINING COURSE ON AERONAUTICAL METEOROLOGY SERVICES

The International Training Course on Aeronautical Meteorology Services will be held in China from 9 to 19 April 2013 by the WMO Regional Training Centre in Beijing (RTC-Beijing), sponsored by the China Meteorological Administration (CMA) and co-sponsored by the Civil Aviation Administration of China (CAAC).

1. Objectives

The course is aimed to enhance the capabilities of participants in the application and interpretation of aviation weather forecast products, and to enhance the nowcasting and the short-term and strong convective weather forecasting ability to improve the issuance of SIGMET (including the content, the format, the quality and the availability) in developing countries.

2. Date and Venue

9 to 19 April 2013, WMO Regional Training Centre in Beijing, China.

Note: Trainees are expected to arrive in Beijing on 8 April 2013 and depart on 20 April 2013.

3. Course Contents

- Developments of aeronautical meteorology;
- SIGMET issuance and related applications;
- Nowcasting methods: (1) the basic knowledge of Doppler weather radar, (2) thunderstorms and strong convective weather elements; (3) thunderstorm generation, development and dissipation of the nowcasting;
- Introduction to the development of China's meteorological service;
- Visit to the operational centres of CMA.

4. Training Format

Lecture, laboratory practice, group discussion, individual presentation, study tour, etc.

5. Instructors

Aeronautical meteorology experts from Air Traffic Management Bureau (ATMB), CAAC, Nowcasting experts from CMA Training Centre, CMA.

6. Language of Instruction

The course will be conducted in English only.

7. Targeted Trainees

Meteorologists who are working in the fields of aviation weather forecasting or other related fields from developing countries.

8. Participants' Qualifications for Admission

Participants are required:

- a) To be specialized in aviation weather forecasting with a minimum of one year's professional experience;
- b) To be in good physical health with no infectious diseases. Physically fit to fulfill all course activities; candidates with limited physical mobility will not be accepted;
- c) To be proficient in English;
- d) To prepare a report on aviation weather forecasting of the participants' service and a brief introduction of the participant's professional experiences for the purpose of exchanges;
- e) Not to bring family members to the training course in principle; if bringing a family member, the participant has to pay the extra expenses;
- f) To observe all the laws, rules and regulations of People's Republic of China and respect the Chinese customs during the training period.

9. Application and Admission

- a) The applicants must be meteorologists who are working in the field of aviation weather forecasting and other related fields from Meteorological and Hydrological Services or Aviation Departments of developing countries. The nominated candidates are requested to submit the Application Forms to RTC-Beijing for examination and endorsement;
- b) Admission Notices will be issued to the accepted participants by e-mail by the RTC-Beijing. With the Admission Notices, the participants are requested to go through all the necessary formalities for entering China and bring all the documents (Admission Notices, Health Document, Application Forms) to RTC-Beijing on the registration date of **8 April 2013**;
- c) Only accepted applicants that receive the Admission Notices endorsed by RTC-Beijing can participate in the training course.

10. Training Expenses

- a) Tuition is free for all the accepted participants that receive the endorsed Admission Notices by RTC-Beijing;
- b) RTC-Beijing will provide local support to the accepted participants from developing countries, including accommodation, meals, and pocket money (50 Yuan RMB per day). Other participants from developed countries shall be responsible for their own local cost;
- c) The international travel costs including round trip tickets, transit fares and subsistence allowance during the travel are to be covered by the participants;
- d) The expenses of visa, medical care, insurances and domestic salaries for the participants should be borne by the participant;
- e) It should be taken into account when booking the flight tickets that the scholarship covers exclusively from 8 to 20 April 2013. Any liability or expense out of this term shall be entirely at the expense of the participants.

11. Insurance

The organizer of the Training Course on Aeronautical Meteorology Services does not hold any responsibility for such risks as loss of life, accidents, illness, and loss of property incurred during the whole period of participation in the training course.

12. Deadline for application

Application shall be submitted and reach RTC-Beijing no later than **2 March 2013**.

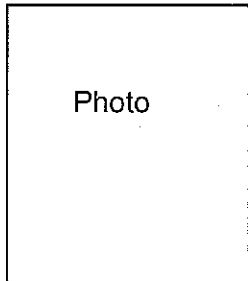
