Dear Colleagues,

The Drought Resilience +10 Conference aims to scale up and accelerate drought action on the ground by "Integrating Knowledge & Practice for Drought Resilience". It will bring together countries, experts and practitioners to review progress and lessons learnt in drought management, and to explore and define a joint way forward towards a more drought resilient world.

Many countries have established drought policies and methods of drought risk management like the three-pillar approach of Integrated Drought Management (IDM) and other approaches have successfully helped to mitigate drought risk in many places around the world. Still, overall, the impacts of droughts on communities, livelihoods, economies and ecosystems are increasing in most regions, particularly in developing countries.

In 2013, several UN agencies, international and regional organizations and key national agencies organized the High-Level Meeting on National Drought Policy (HMNDP) in Geneva. The conference was a watershed moment for drought management and helped to shift the focus from crisis management to pro-active drought management in many countries around the world.

In 2024, more than 10 years after this landmark event for drought management, partners of the Integrated Drought Management Programme (IDMP) are organizing a follow-up Drought Resilience +10 Conference to find new ways to tackle this challenge. IDMP is co-sponsored by the World Meteorological Organization (WMO) and the Global Water Partnership (GWP). The Drought Resilience +10 Conference will take place at WMO Headquarters in Geneva, Switzerland, from 30 September to 2 October 2024.

- Work with political leaders to strengthen awareness, mobilize resources, prioritize drought risk management and increase commitments to building drought resilience and to implement Integrated Drought Management.
