I am writing to request your assistance and cooperation in the provision of weather radar metadata and the appointment of a Focal Point to be responsible for the maintenance of this metadata on behalf or your organization.

In September 2011, a letter was sent to all Members requesting that they nominate Weather Radar Metadata Focal Points in lieu of the operational implementation of the WMO Radar Database (WRD). The letter is available at:

There is now an urgent requirement to ensure that this important source of metadata is maintained on an ongoing basis by WMO Members, through the nomination of Focal Points and their undertaking of the routine procedural requirements.

To this end, WMO is requesting that, if your NMHS operates weather radar and if you have not already done so, that you kindly give consideration to the appointment of an appropriate expert from your NMHS that will act as a Focal Point for Weather RADAR Metadata, whom WMO can contact directly regarding the provision of weather RADAR metadata. The Focal Point would be responsible for initial metadata entry and routine maintenance of the database according to the documented procedures. This will not be an onerous or time consuming exercise but will require a level of technical expertise that facilitates an understanding of weather radar metadata.
