We are pleased to invite you to participate in a one-day workshop, entitled "Operational Climate Services: A dialogue on practical action" being organized on 1 July 2013 in conjunction with the first meeting of Intergovernmental Board on Climate Services (IBCS-1), from 1 to 5 July 2013 at the International Conference Center in Geneva, Switzerland.

This Dialogue builds on the success of the previous "Dialogue on Climate Services Users and Providers; towards implementation of the Global Framework for Climate Services (GFCS)" that took place as part of the preparations of the extraordinary session of the WMO Congress in October 2012. It will focus on the science, policy and resources requirements, and opportunities of climate services and will highlight some best practices from the local, regional and global perspectives.
