Subject: Provision of interpretation into and from the Portuguese language for the

Eighteenth World Meteorological Congress (Cg-18)

Dear Madam/Sir,

I wish to refer to Resolution 46 (Cg-XIV) on the use of Portuguese, adopted by the Fourteenth World Meteorological Congress in May 2003, following consideration of the request presented by Angola, Brazil, Cabo Verde, Guinea-Bissau, Mozambique, Portugal and Sao Tome and Principe.

In Resolution 46 (Cg-XIV), Fourteenth Congress decided that Portuguese shall be used for interpretation at sessions of Congress, subject to the availability of extra budgetary resources, and to continue with existing arrangements for a separate Trust Fund account to provide such extra budgetary resources.

To ensure implementation of the above-mentioned Congress decision, I have continued with arrangements for a special account into which any extra budgetary funds made available for this purpose shall be deposited to meet the cost of interpretation into and from the Portuguese language.

I hereby invite all Members to contribute to this special account so as to enable the Secretariat to provide Portuguese interpretation at the Eighteenth World Meteorological Congress (June 2019). The estimated cost of Portuguese interpretation at plenary meetings of those sessions is approximately CHF 50 933.
