On behalf of the World Meteorological Organization (WMO) and the Intergovernmental Oceanographic Commission (IOC) of the United Nations Educational, Scientific and Cultural Organization (UNESCO), I am pleased to announce that the fortieth session of the Joint WMO-IOC Data Buoy Cooperation Panel (DBCP-40) will be hosted by the Indian National Centre for Ocean Information Services (INCOIS), and will take place at the INCOIS premises, in Hyderabad, India from 22 to 25 October 2024. As decided by the Panel, the session will be conducted in English only. The DBCP Executive Board will meet at the same venue on 21 October 2024.

The expected outcome of this meeting is to improve the data and metadata availability, explore new data sources, and better engage with the buoy data user community. These outcomes will significantly contribute to the high-level objectives of WMO Early Warnings for All (EW4All) and the United Nations Decade of Ocean Science for Sustainable Development (2021-2030).
