Dear Sir/Madam,

I am pleased to inform you that following consultations with the president of Regional Association I and following recommendations of the last RA I Management Group (MG) Meeting in Zimbabwe in November 2011, it was decided to hold an ad hoc RA I MG session (reduced) on the WMO Integrated Global Observing System (WIGOS), in Geneva, Switzerland, from 1 to 3 March 2012.

In this respect, you are cordially invited to attend this RA I MG session. WMO is prepared to provide financial assistance for your participation. The session will be conducted in English and French.

As you are aware, Cg-XVI through its Resolution 50 (Cg-XVI) – WIGOS, requested the regional associations to: (1) develop their regional WIGOS implementation plans; (2) coordinate WIGOS implementation activities with the WMO Information System in their operating plans and work programmes; and (3) promote capacity building and outreach activities to assist Members in the implementation of WIGOS.

Considering the importance and urgency of the WIGOS implementation in RA I that will contribute significantly to enhancing the observing capabilities of all RA I Members needed for the implementation of the Global Framework for Climate Services (GFCS), Disaster Risk Reduction, and other WMO priorities, the RA I-MG-Reduced session will consider the best working approaches for each Subregion and how to address the challenges, while also respecting the specifics of each Subregion.

A provisional agenda of the session is given in Annex I.
