Dear Sir/Madam,

I wish to refer to the WMO letter SG/CER/15-RA II dated 29 May 2012, informing of the fifteenth session of Regional Association II (Asia) (RA II-15) to be held in Doha, Qatar from 13 to 19 December 2012. A document for the session (RA II-15/Doc. 5.1(1)) contains the RA II Management Group proposals for consideration by the Association to establish subsidiary bodies including working groups and their expert groups, and task teams for the intersessional period of the Association.

While the subsidiary body structure is subject to final approval by RA II-15, experience during the previous sessions of regional associations has shown that the selection of individuals to serve for subsidiary bodies is considerably facilitated and improved if information is available at the session on the national experts ready to work in the various fields of the Association's activities.

In this context, I attach a list of the proposed composition of working groups and task teams of Regional Association II (Asia) extracted from RA II-15/Doc. 5.1(1) as Annex I to this letter for ease of reference and invite you to consider the possibility of nominating appropriate experts from your country who could be candidates for undertaking the duties of the following posts during the forthcoming four-year intersessional period:

After RA II-15, in early 2013, RA II Members will be invited to nominate Theme Leaders/members of all working groups and task teams.

Further details on the duties being considered for working groups and their expert groups, and task teams can be found in RA II-15/Doc. 5.1(1). In particular, I would appreciate it if you could nominate active experts who have several years of experience in the relevant fields, the ability to lead a team and who have expressed their willingness to undertake the work for the Association.

These experts should have easy access to such telecommunication facilities as telefax and e-mail. The above conditions help ensure that the experts would be able to fulfill his/her duties and communicate reliably and rapidly within working groups/expert groups, task teams and the WMO Secretariat.

I am pleased to attach herewith a form to be completed by all the experts you may wish to propose for nomination (Annex II). The completed form(s) should be sent to the Secretariat together with **a one-page curriculum vitae** of the expert concerned as soon as possible, preferably **not later than 6 December 2012** in order to ensure that this information will be available for consideration during RA II-15. Pursuant to the WMO policy on gender mainstreaming (Resolution 54(Cg-XVI)), your consideration of both male and female candidates would be highly appreciated. It should, however, be emphasized that such a process will not affect the right of the Association in deciding on the actual formation and composition of its subsidiary bodies.
